Following publication, concerns were brought to the attention of the Editorial Office regarding an unattributed overlap between this article (Ahmad 2021) and a range of earlier publications (United Nations 2010; Asian Institute of Research 2022; United Nations 2012; Chaney 2019; Minority Rights Group International 2008) published by different authorship groups and organizations.

Adhering to our complaints procedure, an investigation was conducted by the Editorial Office and Editorial Board which confirmed a significant overlap between this publication and the abovementioned sources, without appropriate acknowledgement, citation, or permission. The Editorial Board has decided to retract this article as per MDPI’s retraction policy ([https://www.mdpi.com/ethics#\\_bookmark30](https://www.mdpi.com/ethics#_bookmark30)).

This retraction was approved by the Editor-in-Chief of *Laws*.
