

Article **End-to-End Performance Evaluation of MEC Deployments in 5G Scenarios**

Abstract: Multi-access edge computing (MEC) promises to deliver localized computing power and storage. Coupled with low-latency 5G radio access, this enables the creation of high added-value services for mobile users, such as in-vehicle infotainment or remote driving. The performance of these services as well as their scalability will however depend on how MEC will be deployed in 5G systems. This paper evaluates different MEC deployment options, coherent with the respective 5G migration phases, using an accurate and comprehensive end-to-end (E2E) system simulation model (exploiting Simu5G for radio access and Intel CoFluent for core network and MEC), taking into account user-related metrics, such as response time or MEC latency. Our results show that 4G radio access is going to be a bottleneck, preventing MEC services from scaling up. On the other hand, the introduction of 5G will allow a considerable higher penetration of MEC services.

Keywords: MEC; new radio; Simu5G; CoFluent; performance evaluation

1. Introduction

Edge computing has recently emerged as a promising evolution of cloud computing. Its benefits include better scalability, especially when large amounts of data are involved (e.g., acquired from sensors), as well as lower latencies, which enable time-critical services, e.g., remote sensing and actuation or distributed gaming, and the preservation of privacy and context information (including that related to user location and access interface). Many standardization efforts and industry groups gravitate around edge computing [\[1\]](#page-11-0). In particular, Multi-access Edge Computing (MEC) is the leading international standard introduced by ETSI ISG (Industry Standard Group) MEC to define an architecture and services for edge computing [\[2](#page-11-1)[,3\]](#page-11-2), with particular (though not exclusive) regard to cellular network access. This standard includes both an MEC framework and architecture [\[4\]](#page-11-3) and a set of MEC APIs specified following general RESTful API design principles [\[5\]](#page-11-4). According to the definition [\[2\]](#page-11-1), "multi-access edge computing offers application developers and content providers cloud-computing capabilities and an IT service environment at the edge of the network". This environment is characterized by ultra-low latency and high bandwidth as well as real-time access to radio network information that can be leveraged by applications. MEC provides a new ecosystem and value chain. This includes mobile operators, application developers, over the top players, independent software vendors, telecom equipment & IT platform vendors, system integrators, and technology providers, all of whom are interested in delivering MEC-based services.

While MEC is access-agnostic, it is foreseeable that users will conveniently access MEC through cellular networks, i.e., the existing 4G LTE-advanced [\[6\]](#page-12-0) and mostly the new 5G network [\[1,](#page-11-0)[7\]](#page-12-1). Moreover, 5G introduces several innovations, ranging from access to core network side. In particular, 5G New Radio (NR) brings considerable improvements with respect to 4G: access latency is reduced, thanks to of 5G systems on future communications.

several modifications, e.g., duration of timeslots reduced from 1 ms to 62.5 μ s, guaranteeing 16 \times faster scheduling, and the available bandwidth is increased accordingly. This aspect (coupled with the network virtualization) makes MEC adoption particularly well suited to support next-generation services requiring very low latencies and/or high bandwidth, such as vehicular ones (from in-vehicle infotainment to assisted/cooperative driving). In addition, operators can exploit their hosting facilities at the edge of mobile networks and can open their radio access network (RAN) edge to authorized third parties, allowing them to flexibly and rapidly deploy innovative applications and services towards mobile subscribers, enterprises, and vertical segments. More specifically, when implementing MEC in mobile networks, MEC hosts are placed at the edge of the network (e.g., close to the radio access network of a 4G or 5G cellular network) and support MEC applications, leveraging edge services exposed through APIs, e.g., radio network information (RNI) API or location API, helping to tailor their computation based on the network conditions or user location. Other APIs can be exposed to MEC applications following the general design principles of RESTful APIs, to ensure interoperability and portability of MEC applications across different domains. For all these reasons, the focus of this paper is on MEC deployment in mobile networks, also due to the huge business and technology impact

The deployment of the MEC infrastructure should meet different, contrasting needs. On one hand, the infrastructure owner should ensure that its hosts are used efficiently: to this aim, it would be preferable to pool resources relatively far from the users, so that temporal and spatial service usage variability can be met by leveraging statistical multiplexing, aggregating fewer computing resources. On the other hand, low-latency services should, by definition, be hosted as close as possible to the user clients, which pulls towards a capillary distribution of computing resources. Other factors, such as technology constraints (e.g., maximum size of MEC hosts), logistic constraints (e.g., accessibility of sites), or cost aspects (i.e., CAPEX and OPEX), will also play a role. The optimal trade-off point will depend on all these tradeoffs and also on the type of services considered. Finally, the actual MEC penetration will also be influenced by the dominant type of user access technology in a specific area.

Accordingly, since 5G access is expected to dominate in the near future, there is a pressing need for a sound evaluation of MEC services and deployments in 5G networks. Such an evaluation should factor in user-related performance metrics, related to both the computation and communication segments of a MEC service. For instance, the round-trip time experienced by a user for a request-response service will include both the communication latency, i.e., both access, core, and backhaul traversing up to a (possibly far away) MEC host, and to the computation time spent by the MEC app on the host itself, which in turn will depend on contention of shared computing resources (e.g., CPU, memory, storage). From this perspective, it is quite clear that deploying MEC hosts at different locations will affect both the communication latency and the contention on resources (since it will alter the number of users sharing those resources). For all these reasons, performance assessment is key for the evaluation of MEC deployment options. In particular, a proper end-to-end (E2E) evaluation should include reliable models of both the network and the computing environment. This is not easy to achieve in practice, due to the presence of many components, from access to edge and core network, and the need to cover not only PHY and MAC layers, but also traffic models in system-level simulations, and a proper workload modeling of the specific MEC app, related to the use-case under evaluation.

Some existing works (e.g., refs. $[8,9]$ $[8,9]$) rely on numerical evaluations of the system performance, using analytical models. Few simulation tools allow one to simulate applications and services communicating through a 5G network, notably ns3-based 5G Lena [\[10\]](#page-12-4) and OMNeT++-based Simu5G, both of which quite recent. To the best of our knowledge, ns3 does not include models of MEC hosts. Simu5G, on the other hand, does include a MEC host model [\[11\]](#page-12-5), but the resource contention at the latter is not modeled satisfactorily. On the other hand, there are cloud/edge computing simulators, e.g., refs. [\[12,](#page-12-6)[13\]](#page-12-7), which model the computation part but not the communication one. Intel CoFluent [\[14\]](#page-12-8) is one such tool. However, a unified framework, including both communication and computation, is missing.

2.1. Background on Multi-Access Edge Computing 2.1. Background on Multi-Access Edge Computing

In Figure 1 the MEC architecture, as standardized by ETSI [4], is reported. The MEC architecture allows MEC apps to be executed in a virtualized environment, thus enabling dynamic and on-demand allows MEC apps to be executed in a virtualized environment, thus enabling dynamic and onallocation of computational resources in response to users request for a particular task or service. Network operators supervising and managing an instance of a MEC system will be able to optimize resource utilization even dynamically, e.g., by migrating and/or relocating user applications between MEC hosts, following computation and communication requirements.

latency, requested computational resources), selecting and configuring the MEC host that will host and execute the MEC application instance. In a MEC host, a MEC platform provides multiple MEC services, as defined in ref. [\[15\]](#page-12-9). The latter can be used by MEC apps (acting as clients for the MEC platform), to realize complex context-dependent behaviors. Example of MEC services are: the smart relocation service, which allows MEC apps to migrate among MEC hosts (e.g., to follow the least-latency path when users are mobile); the radio network information service (RNIS), which provides information on the state of the underlying network (e.g., how many users are connected, what is the load at the base station, etc.); the bandwidth manager, which sets data traffic priorities within the MEC host; the location service, that can be queried to get access to the users' position. MEC apps run on the MEC host as virtual machines, and they can communicate both with other entities in the MEC host (e.g., the MEC platform, to use its services) and with the outside world (e.g., users' local applications). This is achieved by the virtualization infrastructure.

2.2. MEC Deployment in Cellular Networks

The progressive introduction in the market of MEC technology and its use cases are subject to many (technical and business) decision factors $[16]$. In particular, from a mobile network operator (MNO) perspective, coupling MEC with their plans for progressive introduction of 5G system is a consolidated assumption, especially for those who have a migration path to an NFV-based network (in fact MEC is basically based on virtualized infrastructure, and possibly deployed also in NFV $\,$ environments [\[17\]](#page-12-11)). For this reason, it is of the utmost importance to consider MEC deployment options jointly with MNOs orientations, and coherently with their plans regarding 5G deployment phases. phases. A recent survey from GSMA [\[18\]](#page-12-12) asked operators planning to launch 5G in the next two years A recent survey from GSMA [18] asked operators planning to launch 5G in the next two years which of the 5G Architecture Options (defined in ref. [\[19\]](#page-12-13)) they were considering for their deployment plans. The survey revealed that it is widely expected that mobile operators will initially deploy $5{\rm G}$ using Option 3 (named as 5G NSA, non-standalone) allowing the reuse of existing evolved packet Core $\left(\text{EPC}\right)$ functionality (Rel. 15 early drop), and would require from infra-vendors that the subsequently planned introduction of Option 2 (5G SA, standalone) be not delayed too much (possibly with some intermediate steps, which can be found in the study). Overall, the main phases of the gradual 5G introduction (after the legacy LTE network, i.e., Option 1) are considered in the sequence of Figure [2,](#page-3-0) i.e., starting from Option 3 (5G NSA) and then moving toward Option 2 (5G SA). This paper considers this sequence as a reference for performance comparison when evaluating MEC deployments in 5G systems.

Conline education, advertisement, etc. There are several motivations for this choice, from an industrial perspective. First, automotive is a key sector for both MEC and 5G. These technologies will open the door to multiple use cases and services that can be monetized by 5G Automotive Association stakeholders. Second, in addition to traditional use-cases on connected/automated cars, infotainment is also a promising market. According to [rece](#page-12-14)nt forecasts [20], "Intel predicts a new \$7 trillion passenger economy will emerge when passengers be-come riders"; moreover, the study showed that "drivers spend 300 h a year behind the wheel and 5G offers entertainment opportunities to optimize that time as we transition from drivers to riders". Third, infotainment interests not only automotive stakeholders, but also operators and other content providers, who may be willing to conveniently offer their "legacy" multimedia services for a comfortable in-vehicle user experience. This could be easy to offer, from a shorter time-to-market perspective. From a modeling point of view, infotainment services (as described above) can be represented by many different traffic streams. In this paper, we concentrate the evaluation on a CDN-based video-streaming traffic model.

3.1. Simu5G 3.1. Simu5G

Simu5G [\[21](#page-12-15)[–24\]](#page-12-16) is a system-level simulator for the data plane of the 5G NR technology, based Simu5G [21–24] is a system-level simulator for the data plane of the 5G NR technology, based on $OMNeT++$ [\[25\]](#page-12-17). It evolves from the well-known SimuLTE, which is a library for the simulation of 4G networks $[26,27]$ $[26,27]$. By integrating the INET framework $[28]$, Simu5G allows the evaluation of end-to-end applications, incorporating the whole TCP/IP protocol stack and standard network devices, e.g., routers. It is backward-compatible with SimuLTE, and thus it allows one to simulate also 4G and mixed 4G/5G scenarios. The main components of Simu5G are the User Equipment (UE) and the gNodeB (gNB). Both elements include a Network Interface Card (NIC) module that implements all the gNodeB (gNB). Both elements include a Network Interface Card (NIC) module that implements all layers of the NR protocol stack, as shown in Figure [3.](#page-4-1) The gNB can connect either directly to the Core Network (CN), i.e., in a 5G SA deployment (Option 2), or act as a secondary node (SN) and connected to a master node (MN) implemented by an LTE eNB through the X2 interface. The latter represents the 5G NSA deployment (Option 3) and enables E-UTRA/NR dual connectivity (ENDC) [\[29\]](#page-12-21). In an ENDC deployment, the UE can attach to either the gNB or the eNB, or both. Within Simu5G, this is modeled by endowing the UE with two protocol stacks, one for LTE and one for NR, sharing the packet data convergence protocol (PDCP) layer.

Simu5G supports carrier aggregation, where each component carrier can be configured to use Simu5G supports carrier aggregation, where each component carrier can be configured to use either frequency- or time-division duplexing (FDD, TDD) and different numerologies, thus allowing either frequency- or time-division duplexing (FDD, TDD) and different numerologies, thus allowing maximum flexibility in building simulation scenarios. Simu5G models the effects of path loss,

fading and inter-cell interference on message transmission, without modeling the transmission of individual symbols, which is instead the focus of link simulators such as ref. [\[30\]](#page-13-0). This makes it more scalable, hence apt to evaluate both network- and applications-related aspects in large-scale systems.

of a 5G cellular network. This is useful for rapid prototyping of MEC applications. For instance, Simu5G can be connected to the Intel OpenNESS framework for MEC hosting [\[31\]](#page-13-1). Work [\[22\]](#page-12-22) evaluates

3.2. CoFluent 3.2. CoFluent

Intel® CoFluent™ studio [\[14\]](#page-12-8) is a modeling and simulation tool for optimizing, analyzing, and predicting the performance of complex systems. CoFluent allows one to model and simulate the predicting the performance of complex systems. CoFluent allows one to model and simulate the interactions among both hardware and software elements, thus speeding up the deployment of complex interactions among both hardware and software elements, thus speeding up the deployment of systems. It simulates computing and communication cost with high accuracy and high efficiency, thus it can be effectively used to measure and evaluate the latency and throughput of data flows coming to and leaving from the MEC system. Within this work, CoFluent models a MEC environment, including the User Plane Functions (UPFs) and the MEC app within a MEC host. A high-level view of the latter is shown in Figure 4, and is composed of two main elements: [th](#page-5-0)e UPF and the MEC app. Data arrive at and leave the MEC host through the UPF element, which is further divided into two sub-elements, respectively one for the uplink (UL) and one for the downlink (DL) directions. The processing time T_x required by a packet of size *S*, traversing the UPF in direction *x* is $T_x = S/B_x$, where B_x is the data bandwidth of the UPF in the *x* direction. Packets processed by the UPF are forwarded to a MEC app, which implements the service required by the user and produces a set of data packets as a response. These packets are forwarded back to the UPF, which processes them and sends them back to the RAN. The communication path between the UPF and the MEC app is modeled through two packet queues, one per direction, which have a configurable latency of traversal. The behavior and structure of the MEC app c[an](#page-7-0) be customized to model the required service. In Section 4 we will describe the model of a MEC-based infotainment application.

3.3. Co-Simulation Framework 3.3. Co-Simulation Framework

Our co-simulation architecture enhances the one in ref. [\[31\]](#page-13-1), based on a $4G$ network, incorporates a 5G one. With reference to Figure 5, Simu5G and CoFluent are configured and incorporates a 5G one. With reference to Figure [5,](#page-6-0) Simu5G and CoFluent are configured independently, each with its own models, configuration files and simulation workflows, and also independently. Coordination is achieved via file exchange. Simu5G will simulate the 5G RAN, run independently. Coordination is achieved via file exchange. Simu5G will simulate the 5G RAN, composed of a configurable number of UEs and BSs. Each UE runs an application client, modeling composed of a configurable number of UEs and BSs. Each UE runs an application client, modeling the the behavior of the selected use case, and initiates service requests to the MEC infrastructure. behavior of the selected use case, and initiates service requests to the MEC infrastructure. Requests' data packets traverse the UL of the RAN and the CN and get to the MEC host. The latter generates responses and sends them back to the UE through the DL path. BSs can be either eNBs of gNBs depending on the considered deployment. The structure of the CN depends on the deployment as well. CoFluent instead simulates the CN and the MEC environment. Service requests coming from Simu5G are processed by the MEC host, through the UPF and the MEC app, and CoFluent generates service responses, which are then fed back to Simu5G. The two tools interact via file exchange as follows:

- Step 1: We instantiate a scenario, complete with UE location and mobility, and we run it in Simu5G. In the latter, UEs will generate application-level messages, to be transmitted on the UL leg of the radio access network, destined to the collector. These messages will accumulate delay on their way up, due to user contention, protocol delays, channel quality impairments, etc. The traffic that arrives to the collector (i.e., that exits the RAN) leaves $Simu5G$ as well. We timestamp the traffic, and we log both timestamp and message sizes to Logfile#1 file. More specifically, we log both the simulated time at which a message is generated at the UE, and the simulated time at which it reaches the collector. These times are expressed in Simu5G's units.
- Step 2: We run CoFluent, using Logfile#1 as an input. The MEC elements modeled in CoFluent process the requests generated by the UEs, and the MEC server generates replies accordingly. These replies will contain a payload, which depends on the traffic model used within CoFluent. These replies are sent back to the RAN. Similar to step 1, replies are timestamped and logged These replies are sent back to the RAN. Similar to step 1, replies are timestamped and logged in the Logfile#2 file. In the latter, timestamps are expressed in CoFluent's units. During step 2, time is spent traversing the necessary MEC elements, e.g., queueing up at contention points.
- Step 3: We run Simu5G once more, using the same scenario as for step 1. More specifically, the UE location and mobility are the same. We now use Logfile#2 to generate the replies to be transmitted to the UEs using the DL leg of the RAN. As in step 1, replies accumulate delay due to interference, channel issues, congestion and protocol mechanisms.

We note that file reads and writes are actually made in $C++$ within the co-simulation endpoints. This is done, however, only at the beginning (read) and at the end (write) of the simulation. This allows us to avoid unnecessary file-based operations during the execution of the simulations, thus adding a negligible overhead to the simulation performance. Another benefit of this approach is that it allows us to compute end-to-end delays (e.g., the round-trip time of a request—RTT) without having to synchronize simulated times in the two frameworks. In fact, the RTT can be computed as the sum synchronize simulated times in the two frameworks. In fact, the RTT can be computed as the sum
of the delays incurred in steps 1, 2, and 3, each one of which is computed within a simulator. Thus, if messages keep track of the delay accumulated thus far, the RTT is obtained automatically at the end if messages keep track of the delay accumulated thus far, the RTT is obtained automatically at the end
of step 3. Finally, using a file-based interaction allows us to obtain a co-simulation framework with minimal modification of the two involved simulators, and notably without any impact on their core minimal modification of the two involved simulators, and notably without any impact on their core
functionalities. This last characteristic is particularly important in the perspective of upgradability.

The above co-simulation framework is realized by minimally modifying Simu5G and CoFluent, The above co-simulation framework is realized by minimally modifying Simu5G and CoFluent,
coding some software tools to interface the two. In the UL direction the following elements have been implemented:

- 1. An application that issues service requests periodically at a UE, written in C++.

- 1. A program written in python, mec2simu.py, that parses the MEC packet trace produced by CoFluent, and generates a structured JSON file, which specifies for each packet, its ID, the ID of the UE that generated it, and the timestamp.
- 2. A C++ application that takes the above JSON file as an input and generates a trace of DL messages accordingly. These messages are those that will be injected at step 3, to reach the interested UEs via their serving BSs.
- 3. A C++ application, running on UEs, that collects responses and generates reports (e.g., by computing the RTT of each request and assembling it with some aggregator, say the mean value).

In this section, we assess the performance of a MEC-enabled service in various system deployments. In this section, we assess the performance of a MEC-enabled service in various system Our aim is to highlight the impact and contribution of the different system components (i.e., RAN, CN, MEC host) on the E2E service performance.

The application scenario we consider is an infotainment service, provided in a Cellular Vehicle-to-Everything (C-V2X) environment, whose logical view is shown in Figure [6.](#page-7-1) Each vehicle carries a user client that runs within a UE and connects to a MEC host through the cellular network. The client periodically issues a request for an infotainment service. The server is realized as a MEC $\,$ app residing in a MEC host and responds to requests by sending the client a transcoded version of a prerecorded video stream. On each request, the client specifies one of the video formats reported in Table [1,](#page-7-2) a higher video quality corresponding to a higher bandwidth. The MEC app is composed of two parts: a request handler and a streamer. The former receives and processes the service requests, identifying the video and its format, and notifies the streamer. The latter transcodes and transmits the video stream, one frame each 40 ms. Video frames are finally received at the client, which collects them and computes metrics. In our co-simulation framework, the client is implemented as a UDP application running on a UE on Simu5G, whereas the infotainment server is implemented as an MEC $\,$ app within CoFluent. CoFluent.

- 5G NSA deployment (Figure [8,](#page-9-0) center): the BSs are again LTE eNBs and each of the three central cells also has a gNB placed in the center of the hexagons, connected to the corresponding eNB via X2 and radiating power according to an omnidirectional pattern. The LTE eNBs are connected to a distributed EPC site in proximity of the RAN. Both S-GW and P-GW, as well as the MEC, are considered as virtual network functions (VNFs). Since the path between the RAN and the MEC involves two VNFs, we assume a one-way latency of 200 μ s [\[32\]](#page-13-2). For the X2 interface, we assume 5 ms latency [\[33,](#page-13-3)[34\]](#page-13-4).
- 5G SA deployment (Figure [8,](#page-9-0) bottom): the BSs are gNBs connected to a distributed 5G Core (5GC). Again, the MEC is a VNF connected to (at least) a UPF, acting as PDU session anchor in the 5GC, and terminating to the data network. Since there is only one VNF between the RAN and the MEC, the considered one-way latency is 100 µs.

It is quite evident that, in the 4G scenario, both the RAN and the CN introduce a considerable delay. On the other hand, even high video bitrates are well tolerated in the 5G NSA scenario, and the 5G SA one exhibits negligible delays. In all the three scenarios, the MEC delay is negligible. Figure 11 shows the standard deviation of the frame latency, which measures the jitter, and is a meaningful indicator of user-perceived Quality of Experience. 5. Conclusions and Future Work 5. Conclusions and Future Work

This paper presented a methodology to evaluate MEC deployments with 4G/5G access and the This paper presented a methodology to evaluate MEC deployments with 4G/5G access and the results of its application. The methodology consists in using detailed system-level simulators results of its application. The methodology consists in using detailed system-level simulators (namely, $Simu5G$ and $CoFluent)$ to simulate the communication and computation parts of an E2E service with MEC, and joining them into a flexible co-simulation framework. We have used the above tool to compare MEC deployment options, namely 4G, 5G non-standalone, and 5G Standalone, as for their suitability to support an infotainment service with MEC. Our results show that 4G radio access is going to be the bottleneck from a QoE perspective, allowing only a small number of users, and virtually leaving most of the MEC computation power untapped. With 4G, large jitters will impair the service even in a relatively uncongested RAN. Deploying 5G, already in NSA but especially in the SA option, is going to make a large difference. With 5G, the same service will be able to accommodate considerably more users before MEC hosts become a bottleneck.
