Message from the Guest Editors

Dear colleagues, Several decades into a global disruption caused by the Internet, disabled people often lack access to information communication technology or online spaces. However, even though the digital realm is filled with injustices, many disabled people also feel empowered by their digital technology. New adaptive devices offer disabled people a level of access previously unattainable, with telework platforms opening new employment opportunities for those unable to find accessible employment. The rise of 3D printing and schematic sharing online is slowly changing the relationship between users and manufacturers of adaptive devices. Social media platforms have enabled disability communities to form beyond geographic boundaries and foster an evolving disability culture. These networks provide an opportunity to show their resilience and ingenuity by sharing “life hacks” on how to survive in an inaccessible world. This Special Issue will contribute to the growing interest about disabled people in digital spaces within the discipline of critical disability studies/disability studies.
